# Master of Physician Assistant Studies Admissionss Committee Terms of Reference

# 1. PURPOSE

To oversee all aspects of the student selection and to recommend admission of appropriate candidate learners to the Master of Physician Assistant Studies (MPAS).

# 2. **REPORTING STRUCTURE**

- 2.1 The Master of Physician Assistant Studies Admissions Committee (the "Committee") reports to the Master of Physician Assistant Studies Curriculum Committee.
- 2.2 Subcommittees or working groups shall report to the Committee.

# 3. CHAIRPERSON AND MEMBERSHIP

- 3.1 The Chair of the Committee shall be the Program Director, MPAS (or designate).
- 3.2 The membership of the Committee shall consist of:
  - The Program Director, MPAS;
  - One Faculty member, MPAS nominated by the Nominations Committee and appointed by the Dean, College of Medicine;
  - Three other Faculty members, nominated by the Nominations Committee and appointed by the Dean, College of Medicine;
  - One MPAS student representative, elected annually by the MPAS students; and
  - Other members as recommended by the Chair.
  - 3.3 The Faculty strives to achieve diverse membership on its committees in accordance with the College of Medicine Diversity Policy, and this should therefore be considered when appointing committee members that are not exofficio members.

#### 4. **FUNCTIONS OF COMMITTEE**

- 4.1 The Committee is responsible for overseeing the aspects of the student selection and to recommend admission of appropriate candidate learners to the MPAS, which includes without limitation:
  - Recommending the weighting of factors for admission, interview selection processes, criminal record processes, child abuse background checks, previous employment record checks, and similar processes regarding MPAS requirements;
  - Recommending on all aspects of the eligibility requirements for applicants seeking admission to studies leading to the Master of Physician Assistant

Studies (MPAS) program;

- Recommending on all aspects of the process for selection of applicants for admission to studies leading to MPAS degree, including the criteria for selection;
- Selecting from among the eligible applications those to whom an offer of admission shall be made, in accordance with developed guidelines and criteria;
- Exercising its discretion in determining matters relating to the admission of MPAS students, when not explicitly covered by the rules and regulations of the Faculty of Graduate Studies, the Senate, or otherwise within the University rules and regulations;
- Providing its recommendations regarding the admission of MPAS applicants to the MPAS Program Committee, who in turn notifies the Faculty of Graduate Studies (appeals of all decisions of the Committee must be submitted to the Faculty of Graduate Studies in accordance with its rules); and
- Regular reporting on its activities and providing other recommendations for approval to the MPAS Program Committee.
- 4.2 Committee members shall serve as liaison persons with others in the areas from which they represent.
- 4.3 Committee members, individually and collectively, shall deal with matters before the Committee in such a way that the interests of the Faculty of Health Sciences College of Medicine and the Faculty of Graduate Studies, take precedence over the interests of any of its constituent parts, should those interests conflict or appear to conflict.

# 5. **TERM OF OFFICE**

The term of office of each member shall be for the term the individual is in the position noted in 3.2, or in the case of the Faculty members, for a three-year term with one three-year term optional renewal.

# 6. **QUORUM**

A simple majority of the voting members of the Committee shall constitute a quorum.

# 7. **NUMBER OF MEETINGS**

The Committee shall meet at least once per year, or otherwise subject to the call of the Chair.

# 8. **NOTICE OF MEETINGS**

8.1 Agenda items must be sent to the Committee secretary at least four days in advance of the meeting.
