TITLE: Postgraduate Faculty Lead – Academic Curriculum

REPORTS TO: Program Director, Postgraduate Education

QUALIFICATIONS:

- Certificate from the College of Family Physicians (CCFP) and current membership in the College of Family Physicians of Canada (CFPC)
- Holds a full license from the College of Physicians and Surgeons of Manitoba
- Current faculty in the Department of Family Medicine
- Previous teaching experience in undergraduate or postgraduate Family Medicine
- Interpersonal skills appropriate to dealing with individuals from a variety of backgrounds

BRIEF DESCRIPTION OF POSITION

The Postgraduate Faculty Lead – Academic Curriculum leads the development, coordination and implementation of the post-graduate program's academic curriculum.

DUTIES AND RESPONSIBILITIES:

In addition to the duties and responsibilities outlined in the GFT contract, which outlines duties related to general teaching, the incumbent is responsible for the following related to this position:

1) Administrative

- a) Program
 - Oversee the preparation of a 2-year Academic Day curriculum, which meets
 and respects the standards and guidelines of the College of Family Physicians
 of Canada. Ensure the 2-year Academic Day curriculum in each stream
 includes the PGME Core curriculum and a DFM core curriculum, leaving
 opportunity for stream-specific sessions.
 - Ensure that all streams have comparable in-unit seminars (including behavioral medicine seminars) and journal clubs.
 - Oversee the delivery of the Academic Days content and monitors the evaluation of presenters by the residents.
 - Collaborates with the Faculty Lead QI & Informatics for the delivery of quality improvement and informatics curriculum in the residency program.

- Monitor resident attendance at teaching sessions.
- Collaborates with the education directors in all streams to ensure that content and quality of programming delivered by streams is comparable.
- Explore innovative presentation styles and methods to promote active learning and audience participation.
- Collaborates with Interprofessional faculty to ensure co-facilitation of teaching sessions where appropriate.
