Office of Human Rights and Conflict Management

- A safe and confidential environment to get support with matters related to human rights, discrimination, harassment, and sexual violence.
- Administers and advises on key policies that guide behaviour at the University.
- Educates on human rights, respectful conduct, and conflict management.
- Offers informal conflict resolution services including:
 - Conflict coaching
 - Conciliation
 - Mediation
 - Facilitated dialogue



Office of Human Rights and Conflict Management

- Any member of the University community who feels they have experienced harassment, discrimination, or sexual violence can contact the OHRCM.
- They can get information about their options, referral to other resources, and can choose to file a formal complaint, or to address the matter informally.
- Anyone experiencing conflict can contact OHRCM for coaching, supports, and informal conflict management.
- OHRCM services are confidential within the limits of the law.



OHRCM: Key Policies



Respectful Work and Learning Environment (RWLE)

- Prohibits discrimination, human rights based harassment, and personal harassment



Sexual Violence

- Prohibits all forms of sexual violence including sexual harassment and sexual assault
- Provides supports for survivors



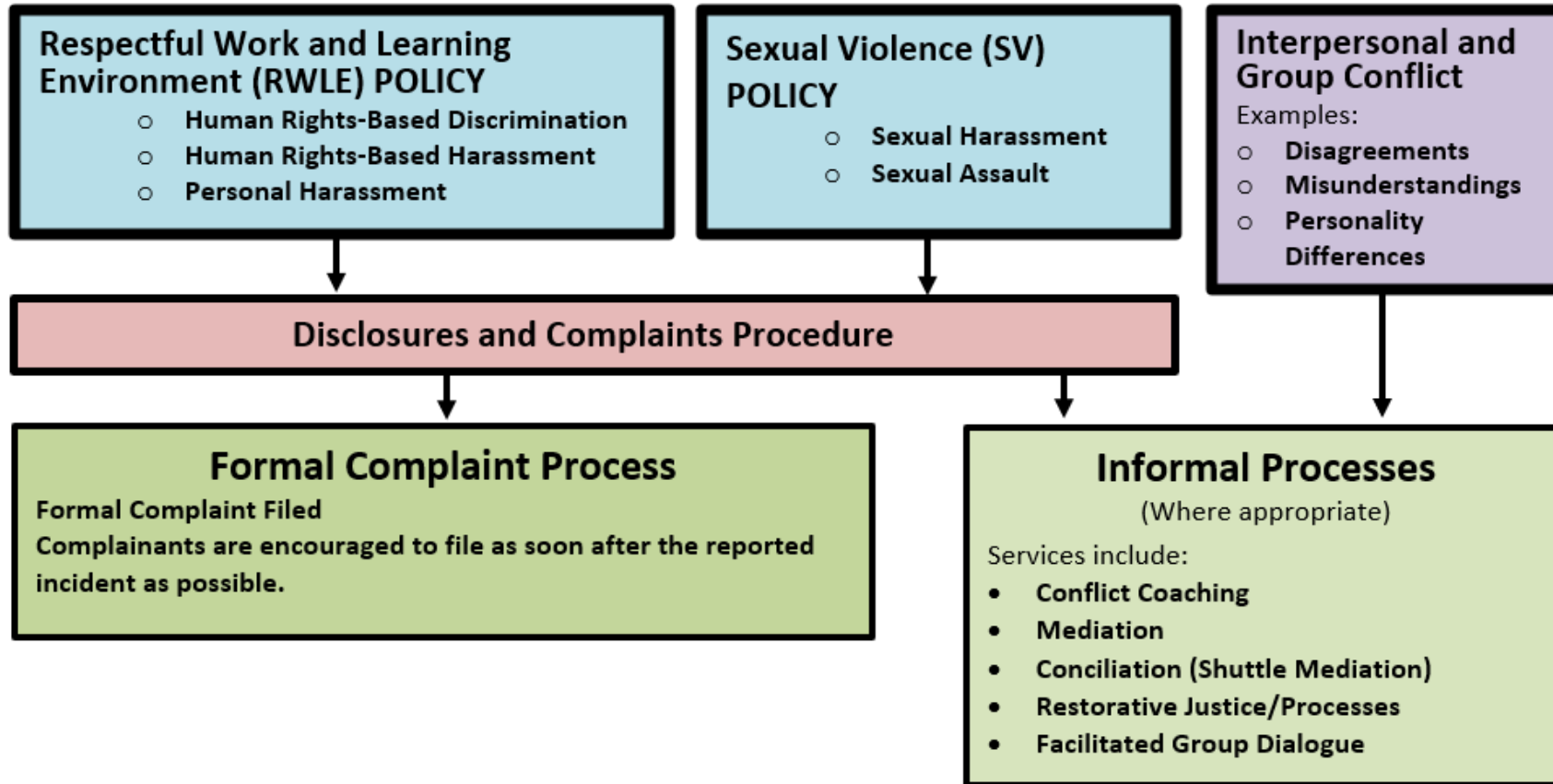
Disclosures & Complaints Procedure

- Outlines process for assessing allegations and conducting investigations

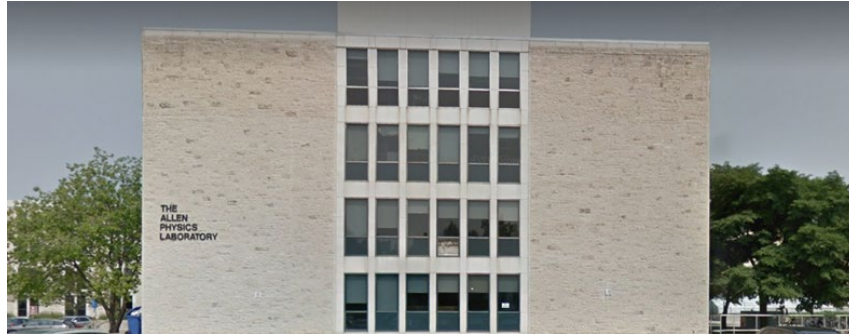


THE OFFICE OF HUMAN RIGHTS AND CONFLICT MANAGEMENT
